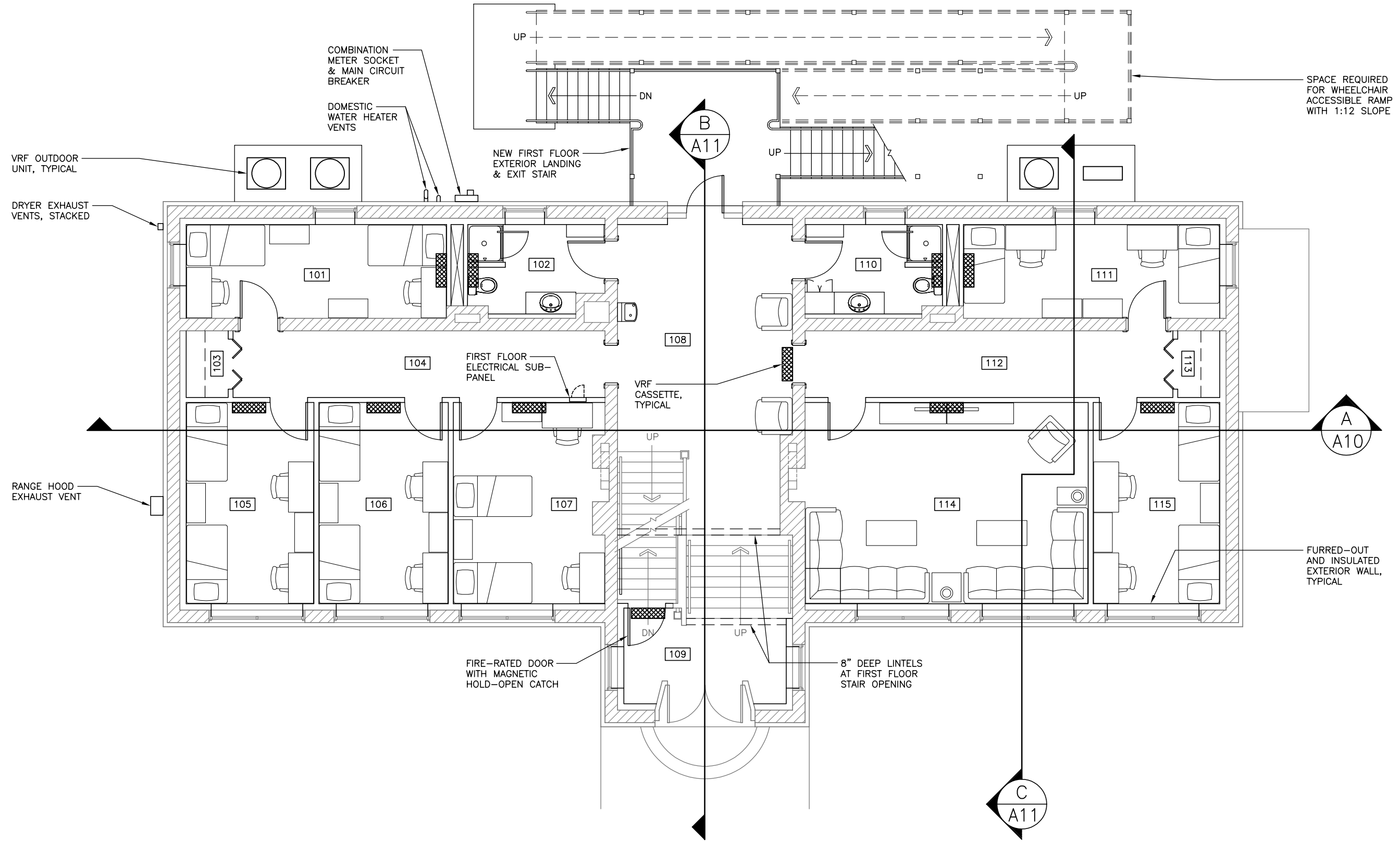


BASEMENT PLAN A

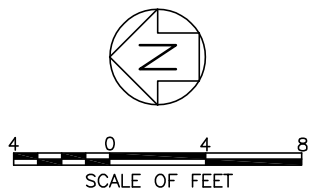

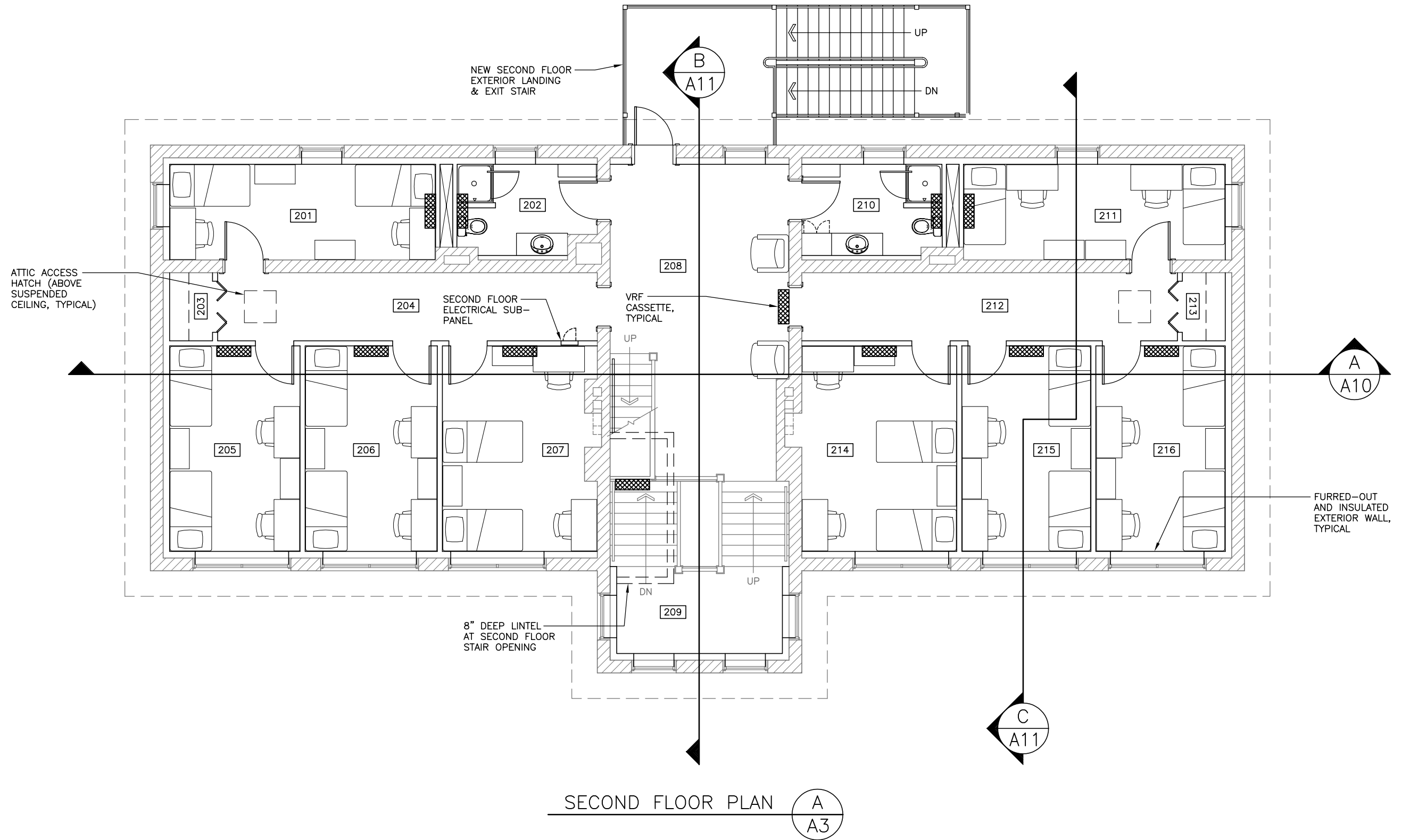


FIRST FLOOR PLAN A

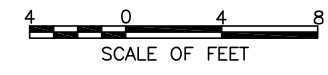
